## SOUTHMONT BOROUGH RESOLUTION NO. 2015-니

A RESOLUTION OF SOUTHMONT BOROUGH, CAMBRIA COUNTY, PENNSYLVANIA, ACCEPTING THE RESIGNATION OF ITS ELECTED TAX COLLECTOR AND APPOINTING A REGISTERED ELECTOR OF SOUTHMONT BOROUGH TO FILL THE VACANCY OF TAX COLLECTOR

WHEREAS, Act No. 43 of the 2012 General Assembly of the Commonwealth of Pennsylvania, "The Borough Code" of Pennsylvania (8 PaC.S.A §101 et seq.) (hereafter "Borough Code"), authorizes boroughs, including SOUTHMONT BOROUGH, CAMBRIA COUNTY (hereafter "SOUTHMONT"), to appoint registered electors of the Borough to fill the vacancy of the elected Tax Collector; and

WHEREAS, SOUTHMONT has received a written resignation from the duly elected Tax Collector of Southmont, Jill Magistro; and

WHEREAS, SOUTHMONT has accepted the resignation of duly elected Tax Collector of Southmont, Jill Magistro, by a majority vote of a quorum of SOUTHMONT council at a public meeting thereby creating a vacancy in the office of Tax Collector; and

WHEREAS, SOUTHMONT has interviewed an individual, Jeanine M. Matse, who is registered elector of Southmont as defined by the Borough Code and who Southmont believes has the necessary skills to serve as the Tax Collector of Southmont; and

WHEREAS, SOUTHMONT desires to appoint Jeanine M. Matse to fill the vacancy in the office of Southmont Tax Collector;

## NOW, THEREFORE, BE IT RESOLVED that:

- 1. **SOUTHMONT** hereby appoints Jeanine M. Matse to the office of **SOUTHMONT** Tax Collector of to fill the vacancy created by the resignation of Jill Magistro; and
- 2. Jeanine M. Matse shall hold the office of **SOUTHMONT** Tax Collector of pursuant to the terms set forth in the Borough Code (see 8 Pa.C.S.A. §901 et seq.).
- 3. By appointing Jeanine M. Matse, to the office of **SOUTHMONT** Tax Collector, she shall have all the powers and satisfy all the duties and requirements as provided by the Local Tax Collection Law, (72 P.S. §5511.1 et seq.) and the Borough Code.


