Additionally, the Limited Lateral Inspection has been performed and the Property passed same.
**Be advised that this Certificate of Compliance applies only to the <u>SEWER LATERAL</u> (foundation to public right-of-way) and does not certify that the under-slab sanitary sewer lines or other portions of the sanitary sewer are not in need of repair or replacement. This Certificate of Compliance does not serve to protect buyers or property owners from being required to fix, repair, or abate groundwater/storm water infiltration into the sanitary sewer system. The Borough continues to test properties for infiltration and if a property is contributing groundwater/storm water into the sanitary system, property owners will be required to abate the problem.
