

RESOLUTION NO. 95-03

BE IT RESOLVED AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE BOROUGH OF SOUTHMONT, CAMBRIA COUNTY, PENNSYLVANIA, AS FOLLOWS:

That, G. Neil Quinn, Tax Collector of the Borough of Southmont, be authorized to exempt, from real property taxation the additional valuation attributable to Twenty percent (20%) of the eligible assessment for the fifth year, Forty percent (40%) of the eligible assessment for the fourth year, Sixty percent (60%) of the eligible assessment for the third year, Eighty percent (80%) of the eligible assessment for the second year, and One Hundred percent (100%) of the eligible assessment for the first year of the properties noted below, in accordance with Ordinance No. 343, Local Economic Revitalization Tax Assistance Act (LERTA) and approved the 14th day of July 1986. (Ordinance 343 repealed by Ordinance No. 371, dated February 20, 1991)


